

Information for the Parish Council Meeting on 26 May 2020

3 Matters Arising (not covered elsewhere on the agenda - for information only)

3.1 Update on the flower verge pilot

Our contractor has confirmed that the seeds have been sown with the exception of yellow rattle.

3.2 Update of Kingsway Green flowerbeds

Our contractor topped up the flowerbeds with top soil and as agreed over email, has sown their recommended wild flower mix which will require minimal maintenance and watering.

3.3 Update on Covid19 community efforts

A verbal report will be given at the meeting.

3.4 Update from Neighbourhood Plan Steering Group ("SG")

The Chairman of the SG has provided the following update:

The SG was in the process of preparing a survey of all parish residents, to help determine the issues to be dealt with in the Neighbourhood Plan and guide the development of suitable policies, when the Coronavirus lockdown was announced, and indeed members of the SG suffered from the virus. The uncertainty caused has meant that a date could not be set for the survey to be carried out, and the lockdown itself has hindered completion of the design and planning of the survey content.

In the meantime the Chiltern and South Bucks Local Plan Examination opened on 17 March, and hearings were then immediately postponed, with the only submissions being placed before the Inspectors, being in relation to Matter no 1....the issue of whether, in preparing the draft plan, proper attention and action had been taken in respect of the legal Duty to Cooperate (DTC) with neighbouring authorities. Having received written submissions and rebuttals from the various affected Authorities and interested third parties, the Inspectors have indicated in letters to the South Bucks and Chiltern Authorities, now of course subsumed into the new Buckinghamshire Council, that they consider that duty has not been met in respect of the relationship with the future housing requirements of Slough BC. They consider it highly likely that this defect cannot be rectified after publication of the draft Plan, and that it may have to be withdrawn. The promoting Councils have been asked to respond to the Inspectors' letter.

The development of the Neighbourhood Plan has a very direct relationship to the content of the draft Local Plan, which the SG had expected to be substantively approved in the coming year. As this issue only became evident in early May, it is not yet known how and to what extent it will affect future progress, but the impact could be very substantial. The SG will consider the matter further when it is able to meet next, and more is known of the Buckinghamshire Council's response to the Inspectors.

9.1 <u>To consider appeal for Gypsy site on Templewood Lane, Stoke Poges</u>

An appeal has been lodged in respect of the refusal of the planning application submitted in respect of the above. The Parish Council's comment in respect of the initial application was:

PL/18/3787/OA - Land On The North Side Of Templewood Lane, Stoke Poges

The location is not identified on the Draft Chiltern and South Bucks Joint Local Plan 2036 as a potential site of this nature. It is also considered that the road is not suitable as it is not wide enough for turning large vehicles and trailers and access is almost on a bend and is opposite the junction with Duffield Lane. In addition, the location is in the green belt and is close to residential housing so the development would be detrimental to the privacy and amenity of neighbours.
