Farnham Royal Parish Council apologises to Councillor Clive Robinson for the distress caused over the past 7 years following his referral to the Monitoring Officer of Buckinghamshire Council and by acting outside of its powers in removing him from his public roles.

Farnham Royal Parish Council acknowledges Councillor Clive Robinson's statements during the public meeting on 17 April 2018 were honestly made and did not bring the council into disrepute.

Although these minutes reflect the words spoken, the Council records (without prejudice to its own position) that in response to a challenge by Mr Robinson to the decision of the Deputy Monitoring Officer for Buckinghamshire Council, the High Court (Administrative Division) held on 20 July 2021 it was an infringement of Mr Robinson's right to freedom of speech to refer him to the Monitoring Officer complaints procedure and to find him guilty of a breach of the Farnham Royal Parish Council's Code of Conduct.
