A resident from Stoke Poges provided an update on The Stoke Poges Task Force's work to prevent Wycombe Wanderers Football Club's plans to build a Football Academy on land at the South Buckinghamshire Golf Course.

Dev Dhillon advised that he had asked the Planning Officers at Buckinghamshire Council to provide definitions of Green Belt and Grey Belt land. He also advised that he would ask for further information about the suggestion that there is more protection for a town rather than a parish in the new National Planning Policy Framework.
